

BVAS' Art Fête 2019: Celebrating the heART of the City.

Opening Reception and Artist Gathering will be held on May 8th, 2019 from 6-8 pm at the gallery in the Ames Center in Burnsville, MN. This exhibit will run May 8th through June 13, 2019.

Please adhere to the criteria below for Art Fête participation:

- Artists may enter one artwork, application includes membership fee of \$40.
- Seniors, (age 65+), and student artists, (age 16-18), membership fee is \$35.
- Submit a JPG image of artwork. Include the following information: Artist's last name, First name, and size by April 22 to burnsvillevas@gmail.com.
- Please note important dates, no exceptions. A late fee of \$20.00 will be charged for artwork not picked up on designated date.
- The artwork must remain at Ames for the duration of the exhibit.
- All artwork must be suitably framed or edges painted on gallery wrapped canvas, wired and ready to hang. Please no zig/zag hangers.
- The artist's name, price and title of work must be secured on the back of the painting.
- Works on paper and vulnerable or dusty media such as charcoal and pastels must be protected under glass or Plexiglas.
- Art Fête is a community art celebration exhibit *** please refer to the Art Fete tab on the BVAS website for additional information.
- All artwork must be original and not previously shown at Art Fête. No prints or reproductions allowed.
- For 2D art: size including frame shall be no greater than 48" wide; maximum height 72". Diptychs, triptychs and polyptychs are considered as 1 piece; not to exceed 48" wide.
- For 3D art: top pedestal surface area shall be no greater than 24" x 24".
- Ames Center handles all sales and requires a 25% commission.
- BVAS reserves the right to refuse the entry of any piece of artwork

Release and Waiver

I, _____, acknowledge and agree to the following provisions:

1. Liability. I am aware that BVAS does not insure the Art Work, and that I must provide my own insurance if I so choose. For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I agree to release and hold harmless BVAS directors, officers and agents of any and all liability, cost or expense, including, without limitation, attorney’s fees, arising from the display of my Art Work, including, without limitation, any claims for damages or lost or stolen Art Work. I further agree to indemnify and hold harmless BVAS directors, officers, and agents from any and all loss, damage, liability, cost or expense that BVAS may incur or suffer as a result of any claim of any kind whatsoever arising from the display of my Art Work.

2. Photography Waiver. I also understand, that by submitting my Art Work, I am granting a license to BVAS to photograph my Art Work and to publish such photographs for promotional, website, and general publicity purposes. I understand that, where possible and at its sole discretion, BVAS will credit my Artwork by listing me as the artist if and/or when any such photographs are published.

3. Art Work Suitability. I further agree and understand that BVAS retains the right to determine any Art Work unsuitable for the above-named Exhibit and decline to accept any such Art Work for the Exhibit, or remove any Artwork from the Exhibit, at any time and for any reason, in its sole discretion.

I hereby represent and warrant that I have read Criteria, Release and Waiver in its entirety, fully understand its contents, and sign it voluntarily and of my own free will.
